Head Constable {Assistant Wireless Operator (AWO)/ Tele-Printer Operator (TPO)} in Delhi Police Examination, 2022 – Declaration of result of Computer Based Examination for shortlisting candidates to appear in Physical Endurance & Measurement Test (PE&MT) and Trade Test – reg.

The Staff Selection Commission conducted Computer Based Examination (CBE) for recruitment of Head Constable {(Assistant Wireless Operator (AWO)/ Tele-Printer Operator (TPO)} in Delhi Police on 27.10.2022 & 28.10.2022.

2. Marks scored by the candidates have been normalized as per the provisions contained in Para-15.8 of the Notice of Examination. Such normalized marks have been used for processing the result.

3. As per the provisions under Para-17.3 of the Notice of Examination, minimum qualifying marks in Computer Based Examination (without adding bonus marks to NCC certificate holders) have been fixed as 40 for UR/EWS, 35 for SC/ST/OBC and 30 for Ex-Servicemen (ESM) category candidates.
